THIS IS A RELEASE OF YOUR RIGHTS TO SUE

I, _____, wish my minor child _____ to enter upon the premises of FineLine Stables LLC and understand that signing this release is a condition of admittance.

I acknowledge that there are inherent risks in being around horses, including, but not limited to, being kicked, thrown, crushed, and bitten. There are also diseases that may be transmitted from horses to human beings.

I shall require my child to wear a suitable helmet at all times that he or she is on a horse at FineLine Stables.

HAVING READ AND UNDERSTOOD THE FOREGOING, I, FOR MYSELF AND FOR MY CHILD, AND FOR OUR RESPECTIVE HEIRS, BENEFICIARIES, AND PERSONAL REPRESENTATIVES, HEREBY RELEASE AND FOREVER DISCHARGE FINELINE STABLES LLC, AND ITS MEMBERS, DIRECTORS, TRUSTEES, OFFICERS, EMPLOYEES, LANDLORDS, VOLUNTEERS, AGENTS, ATTORNEYS, INSURERS, SUCCESSORS, AND ASSIGNS, FROM ANY AND ALL CLAIMS, DEMANDS, DAMAGES, LOSSES, LIABILITIES, RIGHTS, ACTIONS, CAUSES OF ACTION, EXPENSES, AND SUITS OF ANY KIND WHATSOEVER, FORESEEN OR UNFORESEEN, FOR PERSONAL INJURY, WRONGFUL DEATH, OR DAMAGE TO PROPERTY, OCCURRING DURING MY CHILD'S PRESENCE AT FINELINE STABLES OR RESULTING FROM THE ACTS OR OMISSIONS OF THE FOREGOING, INCLUDING ANY AND ALL NEGLIGENT ACTS, WHETHER ACTIVE OR PASSIVE.

I certify that I am such child's parent or legal guardian and have full power and authority to sign this document. In the event that a court of law should hold that this document is not an effective release of my child's rights, then I agree to indemnify the released parties against any losses which they may suffer as a result.
